Event Details:

- All tractors/equipment must be in place on the grounds prior to 9:30 am each day. [Tractors/equipment may arrive either the previous day or the morning of the event].
- Upon arrival, gate attendants will direct Antique Tractor exhibitors to the Pull Gates and Exhibitor Entrance where exhibitors must check in with the Tractors in Technicolour Team.
- For the safety of the public and exhibitors, tractors/equipment can only be removed from the grounds once the gates are closed for the day at 4:00 pm.
- It is mandatory that any and all operators of tractors attend one Safety Briefing session each day (approximately 15 minutes). These are scheduled at 9:30AM. Each operator attending will receive a coloured ribbon at the end of the session which must be worn and visible while operating equipment.

#= ° Rules for Safe Operation of Visiting Vehicles

These rules are for the safety and enjoyment of everyone attending # = ° events. Visiting vehicles includes, but is not limited to, tractors, automobiles, and horseless carriages.

Owners must complete and submit all necessary paperwork for themselves and their equipment **before** attending the event.

Exhibitors are responsible for the security, protection and insurance of their vehicles/equipment while on display and for any liabilities arising from its operation.

Vehicles/equipment must be in good repair and safe operating condition.

Vehicles/equipment must be in place on the grounds prior to event start. For the safety of the public and exhibitors, they can only be removed from the grounds once the gates are closed for the day.

Vehicles may not leave the grounds during the event.

For the safety of all visitors and exhibitors, vehicles are not to be driven around the h grounds during the event. The only exceptions are when a vehicle is being moved into position for #= ° sanctioned activities (i.e. ° h ° u ° u °).

Owners may designate one or more individuals as operators for their vehicle/equipment. Each operator must sign their own Agreement & Waiver and, if relevant, provide proof of valid Driver's Licence for vehicle class.

All owners and operators must attend a Safety Meeting. This is mandatory. No vehicle/equipment may operate with an operator that has not attended.

Exhibitors are allowed to run their vehicles/engines while on display as long as they are not moving.

Exhibitors must stay with their vehicles/equipment while the engine is running.

All exhibitors must provide their own fuel.

When fueling equipment, it should be shut down and cool.

Operators are responsible to ensure that their vehicle is secure when parked and can't roll away.

All vehicle operators must hold a valid Driver's License and \$2,000,000.00 liability insurance.

No person may operate a vehicle who:

- while seated on the seat or standing on the platform, cannot push the brake or clutch down completely
- while seated on the seat or standing on the platform, cannot pull or push the hand clutch or hand brake in or out completely as required to have full control.

Passengers are V\ u permitted in vehicles. Passengers are not permitted on fenders, drawbars or axles.

All owners, operators, and passengers must agree to comply with Country Heritage Agricultural Society rules while participating in CHAS / CHP events. The Country Heritage Agricultural Society reserves the right to refuse applications, equipment, operators, or passengers.

Please read carefully and check each box to signify your agreement:
